Virtual Exhibition Sales

Terms of Reference. The term "Exhibitor" shall include all representatives and agents of any organization to whom space and promotional activities have been allocated for the purpose of participating in the AOGS 2021 Virtual Exhibition program. The term "Exhibition" shall mean the Exhibition referred to in the Order/Booking Form. The term "Organizer" shall mean AOGS 2021 and/or Meeting Matters International Pte Ltd (Meet Matt) also referred to as AOGS Secretariat. The term "Contract" means the contract for virtual exhibition space in AOGS2021 Virtual also referred to as the Asia Oceania Geosciences Society 2021 Virtual Meeting to be held online.

- 1. **Allocation of Virtual Exhibition Space**. Organizer shall allocate the space as it deems fit. We reserve the right to make edits to the space allocated to Exhibitors at any time prior to the commencement of the Exhibition should circumstances demand.
- 2. **Use of Virtual Exhibition Space**. Exhibitors are not allowed to sub-let or assign their dedicated virtual exhibition space to other parties either wholly or in part without the written consent of the Organizer in writing.
- 3. **Terms of Payment**. Unless otherwise specified in writing, all payment must be made 21 days after the invoice date. Non-payment of participation entitles the Organizer to re-allocate the virtual exhibition space to another exhibitor.
- 4. Cancellation/Refund Policy, Breach of contract and/or withdrawal by Exhibitor. If an Exhibitor withdraws from participation this must be confirmed in writing to Meet Matt. The Exhibitor will incur the following charges:
 - Cancellation within 30 days of signature on order/booking form: No charge unless booking is made after 1 Jun 2021 in which case, full cost of participation is payable. Refund of paid bookings will be via same mode of payment less any admin charges
 - Cancellation between 30 days after signature and before 1 Jun 2021: 50% of cancelled participation costs apply. Refund of paid bookings will be via same mode of payment less any admin charges
 - Cancellation on or after 1 Jun 2021: Full cost of cancelled participation payable.
- 5. **Changes in duration of the Virtual Exhibition**. Organizer reserves the right to change the duration of the Virtual Exhibition. In the event of change of duration, the agreement to participate shall remain in force so long as the Exhibitor is informed at least one month prior to such change taking place.
- 6. **Failure of Services**. The Organizer shall not be liable for any loss sustained by the Exhibitor directly or indirectly attributable to cancellation, suspension or reduction of duration of the scheduled Exhibition Activities due to:
 - i. Force Majeure
 - ii. Acts of war, military activity, municipal statutory or civil authority requisition
 - iii. Or any other cause beyond the Organizer's control.

If an exhibition is cancelled, reduced or postponed then in such event, payments made to the Organizer, or any part thereof, may be refunded at the sole discretion of the Organizer to the Exhibitors without prejudice to the Organizer's right to appropriate the entire sum or any part thereof for expenses they have already incurred for the Exhibition.
